6. **Awards:** There will be one Open Winner in each match. Class Awards (in matches 1-6): There will be one award for each 5 competitors. If less than 5 competitors in a class those competitors will be combined with the next higher class. If less than 5 competitors in the High Master class they will compete for open awards only. The same award schedule will be used for the team match. The STATE CHAMPION must be a permanent Connecticut resident. If a non resident wins the match he will be declared the Match Winner and the permanent Connecticut resident with the highest score will be the State Champion.

**General Information:**

**NRA Rules** will govern throughout all matches.

**Firearms:** Any .22 caliber pistol or revolver (NRA Rule 3.4). Triggers may be weighed and will be weighed if National Records are broken.

**Stat Office:** The Stat Office will open for registration one hour before shooting starts.

**Classification:** The NRA classification system will be used in all matches. Unclassified shooters will fire in the Master class. Classification cards will be checked. Assigned classifications may be used (NRA Rule 19.6).

**Scoring** will be done by match personnel. Plug type scoring gauges may only be used by the Match Director or Referee.

**Eye and Ear protection are mandatory.**

**Post entries** will be accepted if space is available.

**Challenges:** A \$2.00 fee will be charged for each challenge. If the challenge is upheld, the \$2.00 will be refunded. Challenge time ends 1 hour after scores are posted.

**Cancellations:** If you reserve a spot and can't make it please let us know so we can fill your spot.

**Team Entries:** Team entries must be made and entry fees paid by the team captain before any member of the team fires the team match. Also the team entry card must be filled out completely before any team member fires the team match. Team entries may be made on the day of the match. **Teams must comply with NRA rules 2.11, 2.13, or 2.14 to be eligible for the Sectional.** Pickup teams will be allowed in the State Championship.

**Squading:** All matches will be squaded and firing points will be randomly assigned by the Statistical Office.

The Connecticut State Rifle & Revolver Association-Pistol Division is pleased to announce its Indoor Pistol Match Schedule. The Indoor State Championship will be held at the MSI Range in February and the Pistol Sectional will be held at Bridgeport Rifle Club in March.

**Direction to Ranges:**

The Metropolitan Shooters Club is located at the Manchester Recreation Center at 281 Garden Grove Rd, Manchester, CT. From I-384 take the Keeney St. exit. Proceed south on Keeney St., take your 5th left onto Garden Grove Rd. The range is located at the top of the hill. Ample parking, food is available from the kitchen. Range phone number is (860) 643-2366.

The Bridgeport Rifle Club is located at 9 Old South Avenue and Woodend Road in Stratford, CT. From the South or West, take I-95 North, take Exit 30 (Lordship Blvd. Rt. 113). Go right at bottom of exit, follow Rt. 113 N. Go left onto Woodend Rd. which is the first left after the 6th traffic light (approx .7 of a mile). Range is .4 miles on right. From the North or East, take I-95 South, take Exit 30 (Surf Ave.) & go left at bottom of exit. Go to the traffic light and turn left onto Lordship Blvd. (Rt. 113 N.). Go left one block after the 4th light onto Woodend Rd. Range is .4 miles on right. Phone number for BRC Range during the match is (203) 377-5830.

***NRA NATIONAL PISTOL SECTIONAL***

1. The NRA Open Sectional National Indoor Pistol Championships are being fired at Sectional Tournaments throughout the United States. They are operated by match staff composed of local match officials. All local challenges and protests are to be resolved on the match site according to the procedures outlined in Section 16 of the NRA Pistol Rule Book. Each individual and team firing in a Sectional will automatically be entered in the National Championship at no additional charge. All fired scores are sent to the NRA where they are compiled and a National Champion is determined.

**Note: "New Rule Change"**  
**Starting in 2019 competitors may shoot in more than one Sectional. Their higher score will be used for the National Record.**

8. Competitors (individual or team) may enter only one NRA Precision Pistol Sectional per year. No one may fire the match for practice.

9. **Awards: Open Awards:** There will be one Open Winner in Matches 1 thru 4 and 6. In Match 5 first place will be given regardless of the number of competitors. There must be a minimum of 8 competitors for second place to be given and a minimum of 12 competitors for third place to be given. **Class and Catagory Awards** for matches 1 thru 6. If fewer than 4 entries in a catagory or class they will be combined with the next higher catagory or class. Competitors of lower classifications will not be combined with the High Master class. If fewer than 4 entries in the High Master class they will compete for open awards only. There must be a minimum of 4 competitors in a class for 1st place to be given, 8 competitors for 2nd place, 12 competitors for third place, 16 competitors for 4th place, and 20 or more for 5th place.

10. Since this is a National Match, an extra entry card must be filled out before the match. Please be sure to indicate your proper classification, catagory and NRA ID # on these cards. Plan to arrive a few minutes earlier than usual to fill out this card and the team entry card.
